VOTING RESULTS OF ANNUAL GENERAL MEETING HELD ON 5 AUGUST 2011

At the annual general meeting of the Company held on 5 August 2011, all proposed resolutions as set out in the notice of AGM dated 6 July 2011 have been duly passed by the shareholders of the Company.

At the annual general meeting of Mobicon Group Limited (the “Company”) held on 5 August 2011 (the “AGM”), all votes on all the proposed resolutions as set out in the notice of AGM dated 6 July 2011 were taken by a poll. As at 5 August 2011, the total number of issued shares of the Company entitling their holders to attend and vote for or against the resolutions at the AGM is 200,000,000 and there were no shares of the Company entitling their holders to attend and vote only against the resolutions or abstain from voting at the AGM.
